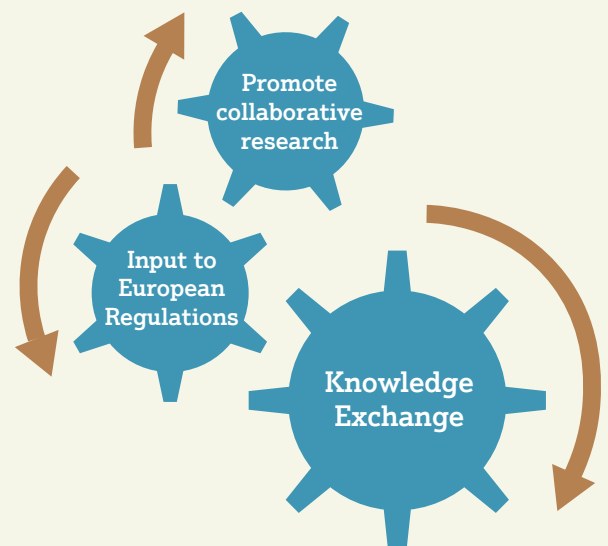
What is NICOLE?
